ORDINANCE NO. 98-10-1  
(Enacted 10-5-98 )

**ORDINANCE TO AMEND THE DOWNTOWN DEVELOPMENT  
AUTHORITY ORDINANCE**

THE VILLAGE OF STOCKBRIDGE ORDAINS:

SECTION 1. Subsection (c) of Section 5 of Ordinance 1100 enacted May 6, 1986, is amended to read as follows:

(c) Open Meeting Act, compliance; rules; special meetings.

The business which the Board may perform shall be conducted at a public meeting of the Board held in compliance with Act No. 267 of the Public Acts of 1976, beings sections 15.261 and 15.275 of the Michigan Compiled Laws. Public notice of the time, date, and place of the meeting shall be given in the manner required by Act 267 of the Public Act of 1976. The Board shall adopt rules consistent with Act 267, governing its procedure and the holding of regular meetings, which shall be held at reasonable times and places, subject to the approval of the Council.

SECTION 2. That this ordinance and the related rules, regulations, provisions, requirements, orders and matters established shall take effect immediately upon publication.


